

[Silverstone Track Day] Terms and Conditions

1. The Promoter

- 1.1 This Competition is operated and managed by Kindred Concepts Limited (a company registered in England and Wales with the company number 12815000) (the **Kindred, We or Us**). You can find everything you need to know about us and this Competition on our website (<https://f1arcade.com/>) and in these Terms. If you have any questions or comments in respect of us or this Competition, you can contact us via our Customer Service Team (available [here](#)).

2. The Competition

- 2.1 The title of the competition is "[Silverstone Track Day Competition]" (the **Competition**).

3. How to enter

- 3.1 The Competition will run from [14:00] on [07.07.2024] (the **Opening Date**) to [17:00] on [07.07.2024] (the **Closing Date**) inclusive.
- 3.2 All competition entries must be received by Us no later than midnight on the Closing Date. We reserve the right to disregard any competition entries received after the Closing Date.
- 3.3 To enter the Competition you must:
- 3.3.1 Play on the React Wall at F1 Arcade London or F1 Arcade Birmingham (the **Competition Entries**)
- 3.4 [The Competition is free to enter]. You may need to have access the internet in order to enter. Costs for this may vary, please check with your service provider for current charges.
- 3.5 We will **not** accept:
- 3.5.1 responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - 3.5.2 proof of posting or transmission as proof of receipt of entry to the Competition.
- 3.6 By choosing to participate in the Competition, you are agreeing to be bound by these terms and conditions.
- 3.7 [The winners of the Competition draw will be the entrant that gets the highest react wall score during the Silverstone Watch Party on [07.07.2024] from all entries correctly submitted in accordance with these terms and conditions.]

4. Eligibility

- 4.1 The Competition is open to all residents in the UK over the age of 18, except our employees (or employees of our holding or subsidiary companies or of our agents or suppliers) or anyone who is professionally connected with the Competition or its administration.
- 4.2 In entering the Competition, you confirm that you are eligible to do so and eligible to claim a Prize. We may require you to provide proof that you are eligible to enter the Competition.

- 4.3 We will not accept Competition Entries that are:
- 4.3.1 automatically generated by computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications);
 - 4.3.2 completed by third parties or in bulk;
 - 4.3.3 photocopies; or
 - 4.3.4 incomplete.
- 4.4 [There is a limit of [one entry per person] and no entrant may win more than one (1) Prize in the Competition.] Entries on behalf of another person will not be accepted and joint submissions are not allowed.
5. **The Prize**
- 5.1 The Prize is a [Silverstone Drive McLaren Experience voucher] (a **Prize**). There will be [1] ([one] winners of the Competition for each venue.
- 5.2 The Prizes are subject to availability and We reserve the right to replace any of the Prizes with an alternative Prize of equal or higher value if circumstances beyond our control make it necessary to do so.

Winners will need to adhere to the general Drive Silverstone Terms and Conditions and driver will need to comply with the driver requirements for the experience."
