What Happens in Vegas Prize Draw Terms and Conditions

1. The Promoter

1.1 This Competition is operated and managed by Raceway Trading Limited (a company registered in England and Wales with the company number 14384787). (Raceway, We or Us). 2. The Competition

2.1 The title of the competition is "What Happens in Vegas Prize Draw" (the Competition). The Competition is made up of two elements: (1) a mechanic that gives an entrant the opportunity to reduce the price of their cocktail to £7 by rolling a seven with two dice (the Cocktail Competition); and (2) a main prize draw where one winner will receive a the prizes referred to in Paragraph 5 of these Terms (the Main Draw).

3. How to enter

- 3.1 The Competition will run from 19 October 2025 (the **Opening Date**) to 11:59pm on 16 November 2025 (the **Closing Date**) inclusive (the **Competition Period**).
- 3.2 All competition entries must be received by Us no later than midnight on the Closing Date. We reserve the right to disregard any competition entries received after the Closing Date.
- 3.3 To enter the Cocktail Competition you must:
 - 3.3.1 Purchase our "What Happens In Vegas Cocktail" (the **Cocktail**) in F1® Arcade London or F1® Arcade Birmingham; and
 - 3.3.2 Roll the two dice provided to you by the team member at the bar.
- 3.4 To enter the Main Draw you must:
